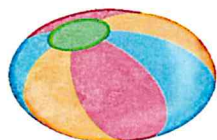

## DORMANT ACCOUNTS

According to state regulation, accounts dormant for three (3) years are deemed unclaimed and will be forfeited to the Texas Comptroller.

WE URGE ALL OF OUR MEMBERS TO MAKE A TRANSACTION ON THEIR SHARE ACCOUNT AT LEAST ONCE A YEAR TO AVOID DORMANCY.

**After 3 (three) years of inactivity, a \$5.00 Dormant fee will be applied to your account monthly until a transaction has occurred.**

Failure to maintain your share account may result in forfeiture of funds in that account.
